UPDATE ON IDPS ACHIEVEMENTS

Since our co-chairs, Canada and Sierra Leone, joined us in mid-2018 we have been busy reconnecting with our constituencies, developing our *IDPS 2019-21 Peace Vision* document and organising a series of IDPS events: a learning event on the margins of the Commission on the Status of Women (CSW) in March in New York; an informal IDPS gathering on 15 May during the SIPRI Stockholm Forum; our first Steering Group meeting on 28 June in Lisbon; and the official launch of the *Peace Vision* and commitments in July at the High-Level Political Forum (HLPF) in New York. With a reinvigorated IDPS and the strong political backing of our co-chairs, 2019 will undoubtedly provide an opportunity to unleash the potential of the IDPS!

RECENT ACTIVITIES

On 12 March 2019, some 70 people gathered in New York on the margins of the 63rd CSW to discuss “The Centrality of Gender Equality to National Cohesion and Sustainable Peacebuilding.” The aim of the event was to raise awareness about the *IDPS 2019-21 Peace Vision*, one of whose thematic focus areas is advancing gender equality and the Women, Peace and Security Agenda to further the delivery of SDG 16+. The event was supported by ministers from Canada, Sierra Leone and Somalia and the First Lady of Sierra Leone, Fatima Maada Bio. It included a panel with two civil society representatives, Visaka Dharmadasa and Anne Kwakkenbos, and a [powerful video message](#) from Hon. Deqa Yasin, Minister of Women and Human Rights Development in Somalia. Click [here](#) for more details.

EVENTS

- ▶ The [SIPRI Stockholm Forum](#) took place on 14-16 May in Stockholm. Michael Callan and other constituency members participated in a panel discussion on "Dialogue in action: a candid conversation on delivering together" on 14 May. The following day Canada also organised an informal IDPS gathering at the Forum for those in attendance.
- ▶ The INCAF Task Team meeting is scheduled for 22-24 May in Paris.
- ▶ The [SDG 16 Expert Group Meeting \(EGM\)](#) will take place on 27-29 May in Rome. In the lead up to the event, CSPPS will be participating in the SDG 16 EGM-Civil Society Day on 26 May.
- ▶ The next IDPS Steering Group meeting will be held on 28 June in Lisbon. A refreshed Steering Group will be meeting in Lisbon for the first time.
- ▶ An "International Conference on Civil Society Space" will take place on 6 June at OECD's Château de la Muette in Paris.
- ▶ The g7+ Justice Ministerial Meeting will take place from 19-20 June in the Hague.
- ▶ The g7+ 5th Ministerial Meeting will take place on 26-27 June in Lisbon.
- ▶ CSPPS is partnering with the Transparency, Accountability and Participation (TAP) Network, International Peace Institute, Saferworld, Peace Direct and others to organise the Voices of fSD16+: Stories for Global Action [video campaign](#) which will culminate in all-day event in New York on 11 July.
- ▶ The IDPS will officially launch its IDPS 2019-21 Peace Vision on the 15 July on the margins of the HLPF in New York. This will be a joint IDPS partnership event with high-level representation from all three constituencies including a group of g7+ ministers presenting their Voluntary National Reviews (VNR) at the HLPF.

"Ready for Review" CSPPS project

CSPPS has joined forces with the TAP Network (and a range of other partners) in 2019 to implement a project aimed at ensuring the meaningful inclusion, participation and contribution of national and local civil society organisations during government-led Sustainable Development Goal (SDG) consultation and validation processes in five countries presenting a VNR at the HLPF in New York in July 2019. g7+ Ministerial Meeting

The g7+ will hold its 5th Ministerial Meeting on 26-27 June 2019 at the g7+ European Hub in Lisbon, Portugal. The meeting will be a key opportunity to gather g7+ Ministers and Focal Points to:

- Consolidate the membership of the g7+ with a view to it becoming an internationally recognised group that exists to make, build and sustain peace and development.
- Develop a consensus on building stability in member countries from within by adapting an introspective approach to tackling challenges that hinder peace and economic resilience.

The g7+ Justice Ministerial meeting will be held on 19-20 June and its International Conference on Natural Resources on 25 June 2019.

FCV strategy

The World Bank is developing its first ever consultative [strategy for Fragility, Conflict and Violence](#) (FCV) in 2019 and is inviting people to share their views and inputs.

The Call to Action will be an important reference for civil society in its engagement around civic space during the lead-up to the HLPF and the UN General Assembly meetings later this year. Release of ODA figures

On 10 April 2019, the Organisation for Economic Co-operation and Development (OECD) released preliminary 2018 [Official Development Assistance](#) (ODA) figures along with a [Communiqué](#) showing that there is a decrease to the world's most needy and a [video](#) explaining the new grant-equivalent methodology.

2nd High-Level United Nations Conference on South-South Cooperation BAPA+40

A landmark conference on the crucial role of south-south cooperation in delivering sustainable development took place on 20-22 March 2019 in Argentina, involving the adoption of an [outcome statement from 160 nations](#).

The g7+ secretariat and partners held a side event on "[South-South cooperation for peace](#)", launching the Fragile-to-Fragile cooperation (F2F) initiative as a unique answer to tackle root causes of conflict and fragility amongst g7+ member states. This event involved representatives of the three IDPS constituencies.
